

## KNOW YOUR DEPARTMENT: POLICY DEVELOPMENT & RESEARCH

### What role does your Directorate play in the department?

Policy Development directorate takes the lead in providing strategic policy advice to the Minister of Police. The directorate focus is on the development, implementation and review of policing and community safety related policies. Policies including The 2016 White Paper on Safety and Security followed by the implementation mechanism, the Integrated Crime and Violence Prevention Strategy (ICVPS) approved by Cabinet were developed. The directorate is also a role player (through various platforms) in crime and violence prevention initiatives in communities through the public consultation process of the draft National Policing Policy.

### What have been your key achievements over the years and recently?

Over the years we have consistently been reaching our targets. In terms of impact matching the effort, I must highlight policies such as the "Policy on Reducing Barriers to Reporting Gender Based Violence and Sexual Offences". The development of that Policy was a challenge and a pleasure at the end. We worked in collaboration with colleagues from all the core units such as COM&E and Partnerships. We really had immense support also from our Supply Chain Management (SCM) colleagues in particular during the national consultations process.

#### What are the challenges that your unit is facing?

Capacity is a real impeding challenge and it threatens our ability to undertake our duties with great efficiency. The other challenge is centred around our dependency on other stakeholders and processes before we can proceed with a planned project. This has serious implications on our output timelines.

#### What major projects are you working on currently?

The Directorate has made a commitment in the APP to finalise the Development of the National Policing Policy (NPP). The NPP gives effect to Section 206 of the Constitution, which provides that the Minister of Police must determine the NPP after consulting the provincial governments and taking into account the policing needs and priorities of the Provinces as determined by the Provincial executives. Furthermore, as part of its commitment to facilitate ICVPS implementation, the directorate plans to market and launch the ICVPS.

## Any other additional information you would want staff to know about your unit?

The 2020 National Policy Development Framework compels departments to conduct socio-economic impact assessments, costing and development of implementation plans for policies and legislation before approval by Cabinet. To comply with this requirement, the Programme is being assisted by a Deputy Director: Policy and Legislation Costing colleague who has been contracted for 12 months whilst a long-term solution is being sought to that effect.

## ENHANCING THE OVERSIGHT ROLE THROUGH RESPONSE PLAN

The increasing crime in the country requires an integrated approach to be implemented in the communities. The Ministry of Police has beefed up the existing crime prevention initiatives by introducing the response plans to ensure a holistic understanding of the causes of crime in communities and the expected approach to crime prevention by people. The Community Outreach unit in the Partnerships Chief directorate, is tasked with facilitating the response plans in communities to identify the challenges and gaps that cause the rise of crime and community dissatisfaction with the police service.

The response plan focuses on a detailed observation of resources and performance of the police stations, the functionality of the CPFs and the relationship between the police, the community and other stakeholders within a policing precinct following the complaints received in a Ministerial imbizo.

To date, eight response plans have been conducted in the 2022/2023

financial year in Kimberely, Mafikeng, Botshabelo, Loskop, Hermanus, Ugu District-KwaZulu-Natal, Sophiatown and Gqebherha following Ministerial instructions to follow up on the issues raised during imbizo. (it is Ministerial and not Minister's because the Deputy Minister also gives directives at an imbizo).

During the facilitation of the response plans, issues such as poor working relationships between the police and the communities and poor functionality of Community Policing Forums are pointed out and discussed in detail as contributing factors that impede effective police service delivery.

Following the response plans, a report with recommendations is compiled to provide SAPS with an opportunity to self-correct and improve the shortcomings identified by communities and stakeholders. The department will continue to heed the Ministerial call to facilitate the response plans to enhance its oversight role over the police and thus improve the state of policing in South





# POLICE MINISTER RETURNS TO RIVERLEA TO ADDRESS ILLEGAL MINING

Police Minister Bheki Cele returned to Riverlea with a strong message for illegal miners, cautioning them that the police are ready to fight fire with fire. Minister Cele was addressing the residents of Riverlea during a visit to the area. He was there to provide feedback on the work conducted by the additional police force deployed to deal with illegal miners. The Minister dispatched various policing units following a protest by the community against crime and illegal miners who were fighting among themselves with the community caught in the crossfire.

The Minister reprimanded the residents who assist illegal miners in operating in the area. He emphasized the importance of collaboration between community members and the police in the fight against crime. Minister emphasized that "it is of great importance that all of us push the same agenda", Minister said. Riverlea residents pleaded with the Minister to fulfil his promise to deal with crime and illegal mining in the area. Residents of Zamimpilo informal settlement also reported said they are relieved that the law enforcement agencies are conducting regular raids in the area.

Minister adviced the community to work with the police and not to cover up for the criminals. His message was clear that "as a resident, do not accommodate the criminals in your area. When the Zama zamas are driven away from you, I plead with you to not reinstate a new group in the community". He also instructed police officers to find armed men and confiscate their guns. He affirmed that "the residents of Riverlea should feel safe and sleep peacefully; they should not sleep at 6pm because of fear of what is happening in their area".



More than 190 people suspected of being involved in illegal mining were arrested since the operation began, most of whom are illegal foreigners. Eliezer Goliath, a resident of Riverlea, commended the Minister for dispatching various policing units to the area. "We have raised our concerns, and the government has listened. I am somewhat satisfied with what is being done this far," said Goliath. During his feedback session, the Minister reported that the police also confiscated illegal firearms and ammunition, stolen property, explosives, gas cylinders and other equipment used during illicit mining activities.



PRESIDENT CYRIL RAMAPHOSA HEARS OF NEGLECT DURING IMBIZO IN ALFRED DUMA LOCAL MUNICIPALITY, KZN:

**30 JUNE 2023** 

President Cyril Ramaphosa accompanied by his Cabinet Ministers visited Alfred Duma Local Municipality. Scores of community members complained about poverty, unemployment, crime, lack of essential services such as water and lack of electricity. The complaints were raised at the Presidential Imbizo that was aimed at enabling direct engagement between the government and the community.

During the Imbizo, the communities shared their concerns regarding crucial issues affecting their daily lives. The main challenges raised by the residents was the lack of essential services such as water and sanitation, electricity, network connectivity, dilapidated roads, unemployment, the R350 social relief of distress (SRD) grant,

Community members also expressed concerns about inadequate policing and rising crime rates in the area. President Ramaphosa addressed these concerns by stating that the Minister of Police, Bheki Cele, would return to uThukela district municipality to work closely with local authorities, MECs, and traditional leaders to resolve issues related to crime and policing.

President Ramaphosa praised the collaboration between municipalities, the Provincial and national governments. The district is mainly rural, and the need to travel long distances to clinics, schools and jobs was raised as another problem.

It was said by the President that "National Government has to co-operate with provincial and local governments because sometimes money is sent back due to lack of capacity at the local level, disrupting progress for delivery of services".

#### PRESIDENT RAMAPHOSA LED THE 8TH DDM PRESIDENTIAL IMBIZO

## AT GA-MOTODI VILLAGE IN LIMPOPO PROVINCE: 14 JULY 2023.


President Cyril Ramaphosa held the 8th District Development Model (DDM) Presidential Imbizo to Ga-Motodi village in Limpopo Province. During his visit, President Ramaphosa engaged directly with the communities and stakeholders in Ga-Sekhukhune. He addressed their concerns on seeking solutions to unblock challenges hindering integrated service delivery.

Challenges were raised by community members. These ranged from constant water and electricity shortages, dilapidated infrastructure, poverty and unemployment. During the Imbizo one resident requested the President to establish two new higher education institutions in the area. He was informed of the region's education challenges with only about 4% of residents who have a higher education qualification. President Ramaphosa supported the call for the establishment of mining colleges, universities or a mining academy in the area to harness the region's potential.

and De Hoop, the region still experience critical water challenges.

Sekhukhune district is known as the mining hub of Limpopo. It also has the potential to become the mining capital of the country. However, residents in the area have struggled to reap the benefits. High unemployment rates, limited access to tertiary institutions, illegal mining, crime, poor infrastructure, and water scarcity are persistent issues. While previous water projects had been commissioned in Sekhukhune, these did not resolve the shortage at all. Government has acknowledged the need to address the ongoing difficulties faced by the local population. The President warned municipalities that failure to deliver on their service delivery obligations is a sign of incompetence which will no longer be tolerated. He also told the community that government will adopt a new approach through the district development model to ensure effective project implementation.





26 MAY 2023

As part of the 2023/2024 financial year commitments, the Minister of Police visited Gqeberha in the Eastern Cape to hand over the newly built police station to the community of Chatty in Booysens Park. The station is one of the 13 new police stations to be handed over to different communities during this financial year. The newly built police station include of Community Service Centre (CSC), holding cells and victim friendly room to accommodate victims and survivors of gender-based violence and femicide amongst other things.

During the handing over ceremony the Minister admitted that there is an extreme shortage of police officers in the country with over 20 000 less police officers since 2020. This shortage has taken the ratio of citizens to police to 363 people per one police officer. Addressing community members, the Minister urged the community to work closely with police by becoming part of the community policing structures that are involved in addressing crime.

Minister Cele also stressed the fact that access to the police station should not be made priviledged, instead it should be a service point which is accessible daily to community members who are in need of police service. The Minister indicated that the police station was part of a strategic deployment of resources. This according to the Minister meant that "residents of any community don't have to walk kilometers to access a police station". He pointed out that the community policing forums have been allocated a budget to assist them to function and to conduct crime prevention work in communities.

The Premier of the Eastern Cape, Mr Oscar Mabuyane, who accompanied the Minister called on the SAPS to continue to improve accessibility to policing services for all South Africans and those who live within the country's borders. He urged the community to work closely with the police by becoming part of the relevant community policing structures to assist police in addressing crime.

The handover of the police station was followed by the community engagement held at a community hall In Motherwell. Community members were given an opportunity to engage and discuss with the Minister the challenges and possible solutions the crime happening in their area. Several community members raised complaints about corruption of police officers in the area. They alleged that police officers are involved in criminal activities and they work with criminals. Other complaints included the lack of protective clothing for patrollers and the abuse of women and children that remain high in the area.

Responding to the issues raised by the members of the community, the Minister gave a directive to the Civilian Secretariat for Police Service to return to Gqeberha to make a follow up on all issues raised by the community regarding the police and the functionality of the CPFs. He directed the CSPS to get an understanding of the causes of community dissatisfaction with the police and provide a report to his office.
